BIDDEFORD: OTHER ISSUES

Premium Parking Staffing-

Due to current funding, only able to have one full time staff for Tuesday-Friday and a part time person who covers weekends plus Mondays. Means only location in compliance all the time is P4301- Pearl St. Garage with sensors reading license plates as vehicles arrive plus exit.

City of Biddeford On-Street Compliance-

Some of those complaining of lack of parking causing slow business are the ones, along with their employees, who shuffle vehicles from parking space to parking space on the block preventing patrons from parking near the businesses. City with one staff on day shift weekdays checking on-street parking means people won't stop playing that shuffle game every few hours so they don't ever need to pay for parking in the surface lots.



BIDDEFORD: RECOMMENDATIONS



- Increase funding for an evening person on staff each day of the week could be created by removing all free parking in the surface lots.
- Downtown On-Street Parking becomes managed for compliance by entering of license plate, two zones of 2 hours or 4 hours free parking be designated by street.
