IN BOARD OF CITY COUNCIL..JANUARY 17, 2017

BE IT ORDAINED, by the City Council of the City of Biddeford that the Code of Ordinances, Chapter 2, Administration, Article V FINANCE, **Add Section 2-329- Exempting Eligible Active Duty Military Personnel From Vehicle Excise Tax** to read as follows:

Section 2-329 - Exempting Eligible Active Duty Military Personnel From Vehicle Excise Tax

a) Authority.

This ordinance is enacted pursuant to 36 M.R.S.A. § 1483-A, which expressly authorizes such ordinances.

b) Excise tax exemption; qualifications.

Vehicles owned by a resident of this municipality who is on active duty serving in the United States Armed Forces and who is either permanently stationed at a military or naval post, station or base outside this State or deployed for military service for a period of more than 180 days and who desires to register that resident’s vehicle(s) in this State are hereby exempted from the annual excise tax imposed pursuant to 36 M.R.S.A. § 1482.

c) Application for exemption.

To apply for this exemption, the resident must present to the municipal excise tax collector certification from the commander of the resident’s post, station or base, or from the commander’s designated agent, that the resident is permanently stationed at that post, station or base or is deployed for military service for a period of more than 180 days.

For purpose of this section, “United States Armed Forces” includes the National Guard and the Reserves of the United States Armed Forces.

For purpose of this section, “deployed for military service” has the same meaning as in 26 M.R.S.A. § 814(1)(A).

For purpose of this section, “vehicle” has the same meaning as in 36 M.R.S.A. § 1481(5) and does not include any snowmobiles as defined in 12 M.R.S.A. § 13001.

d) Effective date; duration.

This ordinance shall take effect thirty days after its adoption by the City Council and shall remain in effect unless and until it or 36 M.R.S.A. § 1483-A is repealed.

NOTE: The Policy Committee considered this item at their March 13, 2017 meeting and voted unanimously to forward to the City Council for approval.

Motion by Councilor Quattrone, seconded by Councilor Swanton to move into Committee of the Whole.

Vote: 6/2; Councilors Ready and Mills opposed.

Councilors Swanton, McCurry, St. Cyr, Quattrone, Belanger and Seaver in favor.

Motion carries.

Time: 6:40 p.m.

Councilor McCurry stated that he has received calls from folks who support bringing alcohol back to LaKermesse. He’s not completely averse to the idea; however, does not want to give a blanket approval, but rather, look at events on a case by case basis. He also would like to see a policy be adopted by the Council regarding alcohol consumption on City fields/parks.

Councilor Swanton said that he would support LaKermesse having permission to serve alcohol. He is also in favor of RiverJam serving alcohol at their event; however, he is not in favor alcohol consumption in Shevenell Park (as was requested by Palace Diner).

Councilor Quattrone stated that he too has received phone calls from folks supporting alcohol consumption at LaKermesse. He stressed that the organization uses security precautions and alcoholic beverages are only served in a designated, roped off area. He also would support alcohol consumption in some of the City parks, as long as it's contained (under a tent) and done properly. He went on to mentioned that LaKermesse is proposing to limit the alcohol consumption to certain hours during the Festival and not make it like an all-day drink fest.

City Manager, Jim Bennett suggested that if the majority of the Council is in favor of considering alcohol consumption on a case by case basis for events that take place in City fields/parks, that Staff can draft a policy which will be placed on the next Policy Committee agenda for consideration and recommendation.

Councilor Mills expressed his support for the idea of case by case basis considerations for alcohol consumption in City fields/parks.

Councilor Ready stated that he is not in favor of alcohol consumption in any of the City fields and/or parks. He believes that by allowing alcohol to be served in a family atmosphere event, the wrong message is being sent to the children of the community that alcohol is needed to have a good time.

Councilor Seaver said that she agrees with the City Manager that the current ordinance would need to be addressed if the Council were to consider alcohol consumption in City fields/parks during events. That said, she has an issue with events being considered on a case by case basis, and fears that it could open the City up to a discrimination claim. She isn't personally in favor of the idea, but is more concerned about having a policy in place.

Councilor Belanger noted that if the City is going to consider the idea of alcohol consumption in City fields/parks, then a provision for liability insurance would need to be included to protect the City from any potential damages.

Councilor Quattrone asked if including certain provisions in a proposed ordinance would be possible. Mr. Bennett explained that it would be easy enough to look at other communities' policies and piggy back off them. Councilor Quattrone's concern is the timing of putting a policy into place since LaKermesse would need to apply for the proper State licenses. Mr. Bennett assured him that something could be put together prior to the next Policy Committee meeting, but made no promises that such a policy could be established as quick as would be needed for this year's LaKermesse Festival.

Councilor Mills asked Recreation Director, Carl Walsh about the insurance provision that was brought up by Councilor Belanger and if the Special Event Permit policy would cover that provision with this provision already a part of the application.

Motion by Councilor McCurry, seconded by Councilor Mills to move out of Committee of the Whole.

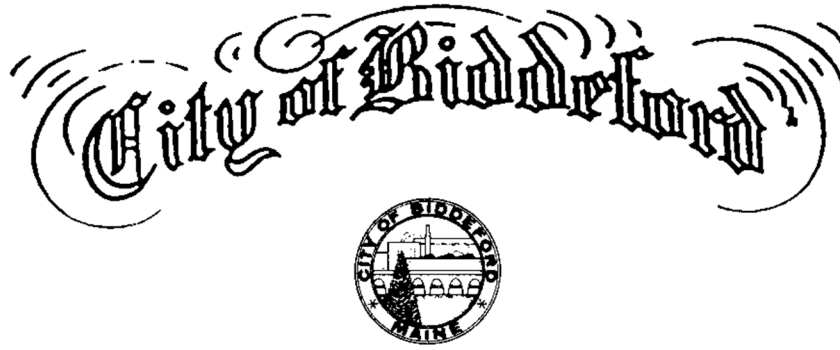

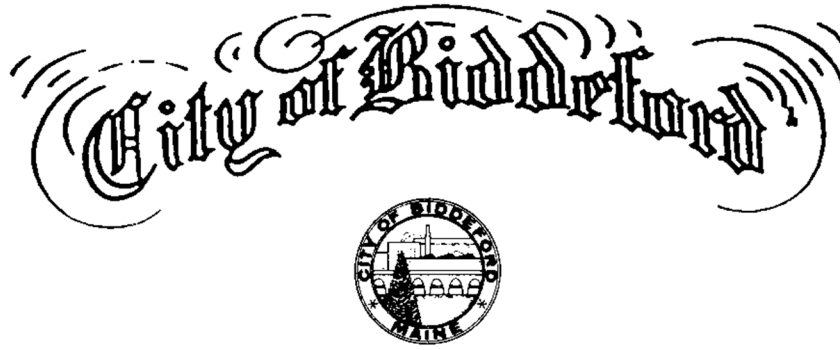

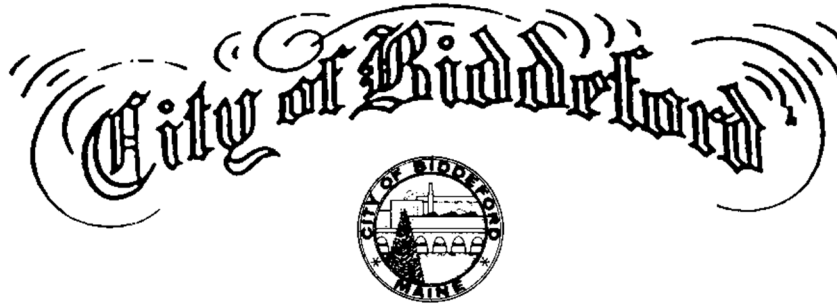

BE IT ORDAINED, by the City Council of the City of Biddeford that the Code of Ordinances, Chapter 2, Administration, Article V FINANCE, **Add Section 2-329-Exempting Eligible Active Duty Military Personnel From Vehicle Excise Tax** to read as follows:

Section 2-329 - Exempting Eligible Active Duty Military Personnel From Vehicle Excise Tax

a) Authority.

This ordinance is enacted pursuant to 36 M.R.S.A. § 1483-A, which expressly authorizes such ordinances.

b) Excise tax exemption; qualifications.

A motor vehicle owned by a resident of this municipality who is on active duty serving in the United States Armed Forces and who is either permanently stationed at a military or naval post, station or base outside this State or deployed for military service for a period of more than 180 days and who desires to register that resident's vehicle in this State is hereby exempted from the annual excise tax imposed pursuant to 36 M.R.S.A. § 1482. Only one motor vehicle per qualifying resident shall be eligible for the exemption.

c) Application for exemption.

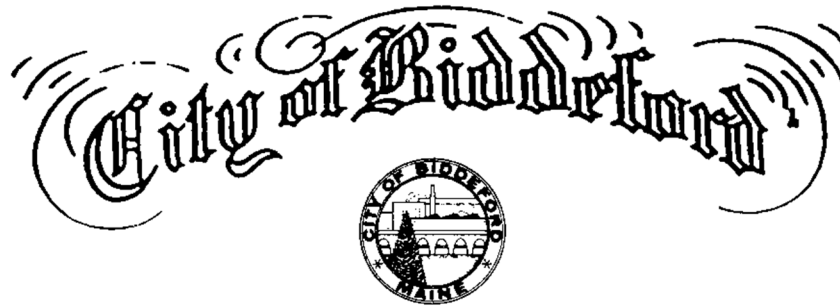
To apply for this exemption, the resident must present to the municipal excise tax collector certification from the commander of the resident's post, station or base, or from the commander's designated agent, that the resident is permanently stationed at that post, station or base or is deployed for military service for a period of more than 180 days.

For purpose of this section, "United States Armed Forces" includes the National Guard and the Reserves of the United States Armed Forces.

For purpose of this section, "deployed for military service" has the same meaning as in 26 M.R.S.A. § 814(1)(A).

For purpose of this section, "motor vehicle" has the same meaning as in 36 M.R.S.A. § 1481(3) and does not include any snowmobiles as defined in 12 M.R.S.A. § 13001.

d) Effective date; duration.



This ordinance shall take effect thirty days after its adoption by the City Council and shall remain in effect unless and until it or 36 M.R.S.A. § 1483-A is repealed.

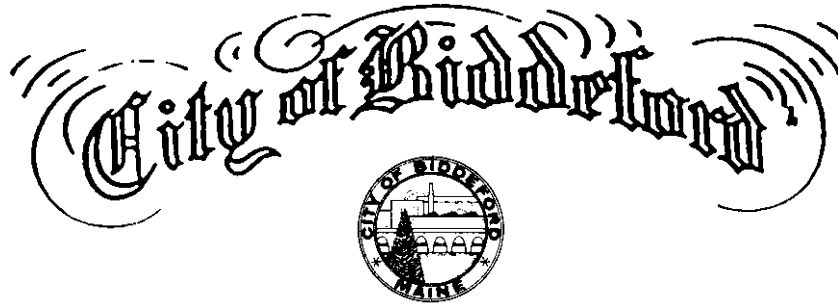

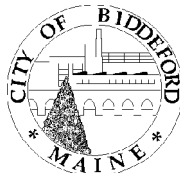

The City of Biddeford requested bids by public advertisement in the Biddeford Journal Tribune for the above named project. The bid advertisement was also posted on the City of Biddeford's Web Site. The bids were opened on March 28, 2017.

The project work area is on Mile Stretch Road from Bridge Road to Lester B Orcutt Blvd. A location map is enclosed.

The project is a drainage improvement project to enhance drainage on this section of roadway prior to the road being repaved this spring.

Six (6) construction firms requested the plans and specifications for the work. Two (2) firms submitted bids for the project. Bidding results are attached. Pratt and Sons Inc. of Mechanic Falls, Maine, submitted the low bid. Based on a review of the bids, check of references, and prior satisfactory work within the City on the Orchard Street CSO Separation project, Pratt and Sons Inc. appears to be qualified to perform the work. Therefore, Staff recommends that Pratt and Sons Inc. be awarded the contract work.

The contract is a unit cost contract and only those items supplied and installed will be paid. Funding for the work will come in part from the MDOT MPI grant received by the City with the required City match from the 2009 Road Improvement Bond passed by voters.

The project is on fast track in order to have the work completed this Spring prior to Memorial Day. Therefore, staff is respectfully requesting both the Finance Committee and City Council review and take action on the project at their April 4, 2017 meeting.
